NOTE.

1	Only Firms/Contractors registered as General Order Suppliers with valid registration and having experience in supply of above mentioned items will be entertained.
2	All above mentioned items are to be counted different items and for each item separate bid / offer is required. However one person can apply for one / all categories and can win the contract as mentioned above also.
3	Detailed specifications and quantities are mentioned in the Tender Forms.
4	Bid validity is for a period of 05 months (August-2022 to December-2022) extendable for another 06 months up to June-2023.
5	All the procurement procedure will be adopted as required under PPRA, Rules 2014 (Amended).
6	The bidders are required to submit bid / offer under single stage one envelope procedure, separately for each category as mentioned above, as per Rule 38(1) of Punjab Procurement Rules, 2014.
7	CDR / Demand Draft / Pay Order for the amount as mentioned against each bid / offer in favour of Principal Cadet College Okara must be attached with the Technical Proposals of each item separately.
8	The bids should reach by 02-08-2022 till 10:30 AM in the Office of Principal Cadet College Okara. The tender will be opened on the same date at 11:00 AM in the presence of the bidders / representatives who desire to participate in the bid opening.
9	Separate tender form for each item containing specifications, detailed terms and conditions may be obtained on written request at company letterhead pad from the office of the undersigned on any working day from 0900 to 1300 hrs against non-refundable cash payment of Rs. 1000/- for each Tender Form separately.
10	The interested contractors / firms should be active tax payers on FBR. The deductions at source of all relevant taxes at the prescribed rates are applicable.
11	The procuring agency reserves the right to reject all proposals at any time prior to the acceptance of bid or proposal as per Rule 35 of PPRA 2014.
